I would like to make a request for the following information relating to Health Education Funding provide by SECAmb.

Could I ask how many applications were *granted* via TED applications or otherwise for:

- The specific course/titles
- Associated universities
- Amount of funding granted per course

and which department the staff member was associated e.g. A&E operations, clinical education, medical directorate etc

As per the TED procedure, 25%, 50% or 100% funding was allocated to successful applications based on the necessity rating of the activity as given by the applicant's line manager.
