- 1. The number of requests made for ambulances to attend each site;
- 2. The date (or month) of each such request (this can be in aggregate across all sites to prevent individual calls being identified);
- 3. Information on the broad medical reason for each such call-out, broken down by heading (this can be in aggregate across all sites to prevent individual calls being identified).

I would be grateful if this information could be provided as an Excelcompatible file for the period of the financial years 2016/17, 2017/18, 2018/19, 2019/20, and 2020/21.
