You requested the following information, please also see our response below:

1. The total amount spent on private ambulances and transport by this Trust in the financial years 2019/20, 2020/21 and 2021/22.

Please provide yearly subtotals and a breakdown of cost by if services were used for 999-calls or non-urgent transfers.

Our private ambulance providers have only provided services for 999-calls for the 3 years. The amount spent by year is:

We pay our private ambulance providers by an hourly rate to provide ambulance shifts and therefore we do not get charged per trip/visit, the three most expensive incidents were:

- £840.04
- £782.36
- £757.61
