Q3b-d The specific complications are not recorded separately as condition codes. I have provided the total of incidents where either 'disorder of pregnancy' or 'complication of pregnancy, childbirth and/or puerperium' have been recorded on the patient clinical record.

Patient clinical records that have two 'pregancy and labour' type condition codes may be included more than once in the totals. For example a record with 'labour' and 'post partum haemorrhage' would be included in Q3a and also Q3f.

Q3f this figure does not include any calls where the crew has not selected labour as a crew condition on the Patient Care Record (PCR). I hope you find this information of some assistance.
