I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI 240416.

You requested the following information, please see our response below:

I am writing to you under the Freedom of Information Act 2000 to request the following information from Human Resources and/or Payroll. Please may you provide me with:

 The exact formula or algorithm used to calculate "Ann Leave Cor OT" payments

Currently the payments being made based on the Ambulance Trust Agreement of 13% of the total previous months additional hours, overtime and recall to duty.

The criteria under which payments are calculated

Only additional hours, overtime and recall to duty are included within the monthly "Ann Leave Cor OT" payment as section 2 is calculated separately through GRS.

The dates or schedule on which "Ann Leave Cor OT" payments are paid

Payments are made monthly based on the previous months additional hours, overtime and recall to duty.

The exact formula or algorithm used to calculate section two lower rate hours accrued when an employee is on Annual Leave, Time Off In Lieu or sick

The current calculation for Section 2 Unsocial Hours (USH) lower and higher is the same and is applied to as follows.

USH for Annual Leave (AL) & Time off In Lieu (TOIL)

o If the AL or TOIL is taken off and there is an underlying shift on the rota then the USH hours are paid at the rate for the underlying shift.

Example:

USH- Lower applied	11.5	0	0	0	0	9.5	0

 If the AL or TOIL is taken off without an underlying shift (Relief shifts) then a 365 rolling daily average of the total unsocial hours (lower & higher combined) is applied to shifts that have a relief value.

Example:

USH- Lower applied	0	0	Rolling average	Rolling average	0	Rolling average	0

Sickness does not attract unsocial hour payment.

Please Note that we are currently reviewing the application of section 2 USH allocation in partnership with our Trade Unions.

 The exact formula or algorithm used to calculate section two lower higher rate hours accrued when an employee is on Annual Leave, Time Off In Lieu or sick
