You requested the following information, please also see our response below:

I'd like to make a request for information please regarding applications for ambulance technician roles as the current adverts are somewhat unclear, within part of the advert it states the QA Level 5 Diploma in First Response Emergency & Urgent Care (FREUC5) is accepted as an alternative to BTEC Level 3 Ambulance Aid / IHCD Technician. However in the job description it does not contain any information on the FREUC5 qualification being acceptable? Please can you confirm the following.

Could you please clarify,

- 1. What pre hospital qualifications do you accept for external applicants for ECSW experienced adverts?
 - 1. Level 3 Certificate in Emergency Response Ambulance driving and Valid IHCD Emergency Driving qualification.
 - 2. At least 2 years on a front-line ambulance experience as ECA or ECSW
 - 3. C1 Licence
 - 4. L3 diploma qualification for ECSW, however where this is not held consideration escalated to the Consultant Paramedic for view.
- 2. What pre hospital qualifications are accepted for private ambulance providers for the equivalent to ECSW or ECA grade?
 - 1. As above
- 3. What pre hospital qualifications do you accept for external applicants for technician roles.
 - Full IHCD Technician certificate only or equivalent BTEC Level 3
 Ambulance Aid awarded through Pearsons

- 3. Level 3 Certificate in Emergency Response Ambulance driving and Valid Emergency Driving qualification.
- 4. What pre hospital qualifications are accepted for private ambulance providers for the equivalent to Technician grade?
 - 1. As above
- 5. Is specifically the FREUC5 qualification accepted as technician equivalent for external applicants?
