I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI 240108.

You requested the following information, please also see our response below:

The County Council is looking at ways to improve the pavers within East and North Streets in Chichester City Centre to prevent trips and falls which are increasingly affecting our community, particularly the over 60s. In order to support the business case and provide evidence about the incidence and likely costs of trips and falls, we are gathering data around the number of calls made to the ambulance service due to trips and falls in East and North Streets only – not within the whole of the City centre. We are aware that you are not able to provide this data based on a specific post code therefore we are asking if you can provide a full list of calls made to the ambulance service in Chichester city entre and we can then scan through the list ourselves.

To support the business case it would also be important to provide data around the economic impact of trips and falls, so can you please provide data about the cost of calls made to the ambulance service and any other cost associated with it, e.g. if someone needs further treatment/ hospitalisation/physiotherapy.

Please find below a table showing the total cost of attending trips and falls within East and North Streets only in Chichester City Centre over the past 5 years.

These costs consist of providing a 999 emergency response only, we are unable to provide any costs relating to any further treatments received as we do not hold that data.

We are however able to provide the numbers transported to another health provider (typically A&E).

Calls that were identified and categorised during telephone triage as one of the following:

- Fall Head
- Fall Stairs
- Fall Injuries Unknown
- Fall Non-injury

Count of all incidents = Where at least one resource arrived at scene or where treatment or advice was provided over the phone.

Count of attended incidents = Where at least one resource arrived at scene or where treatment.

Count of incidents over 60 years= Where at least one resource arrived at scene or where treatment or advice was provided over the phone and the patient was recorded as over 60 years old.

Count of attended Over 60 years = Where at least one resource arrived at scene or where treatment and the patient was recorded as over 60 years old.

Please note that we are unable to confirm if these incidents took place inside or outside.

Less than 10, we are unable to provide exact figures as these could be identifiable to individuals.
