4. Current Vacancies at the trust per Specialty: General Nurse/ Mental Health **Nurses/ AHP/ Doctors**

As an Ambulance Trust we do not hold any vacancies for 'Specialty: General Nurse / Mental Health Nurses / Doctors'. AHPs cover our clinical (paramedics etc.) workforce. There are currently 95 whole time equivalent (WTE) vacancies within our service.

5. During the financial year 2023/24, which international recruitment partners did the trust use, if any? Who are they planning to use for 2025/26? Who is the responsible officer who decides this?

The Trust did not use any international recruitment partners during 2023/24; this was managed by Trust staff. The Trust does not hold any information concerning plans or decisions in this regard.

7. What was the international recruitment spend Bifurgted by Doctors/Nurses/AHP by the trust for the financial year 23/24?

The Trust expenditure in 2023/24 on international paramedic (AHP) recruitment was £764,624. No recruitment expenditure was identified for international doctors or nurses.
