You asked us:

- Q1) In the months of September, October, November and December 2023, how many patients were admitted to hospital following complications or side effects of Semaglutide (Wegovy), Ozempic or Mounjaro? (Weight loss jabs)
- Q2) In each month of the calendar year 2024, how many patients were admitted to hospital following complications or side effects of Semaglutide (Wegovy), Ozempic or Mounjaro?
- Q3) What are the three most common side effects of weight loss jabs reported by patients who've been admitted to hospital after using them? Please provide a percentage of each, if available.

Please provide an individual figure for each of the 16 months requested, rather than a total figure.

Note: Incident counts includes all conveyances where one of the drugs in question is mentioned. This includes incidents where ailment is due to suspected side effects, ailments where the fact the patient is on the drug is mentioned, and incidents where a patient has come off the drug and/or is taking an alternative due to e.g. supply chain issues.

Less than 10, we are unable to provide exact figures as these could be identifiable to individuals.

With regards to providing analytical information, the Trust complies with the ICO Anonymisation Code of Practice. This stipulates that when providing information organisations adopt the use of less than 10 is applied in instances where there are low numbers. By applying these parameters we are reducing the potential linking of data and making this identifiable.
