Vacancy rate for 2024/2025 is 3.2% and turnover rate is 40.65%

- a) 2023/2024:

Less than 10, we are unable to provide exact numbers as these could be identifiable to individuals.

The Trust can confirm that this information exists. However, where an output represents fewer than 10 individuals or incidents in the period requested, we have not provided exact figures. This practice is known as data blurring, which serves to mitigate against the risk of possible re-identification of individual data subjects via data recombination (sometimes referred to as jigsawing). This risk is assessed in accordance with the Information Commissioner's Office (ICO) *Anonymisation Code of Practice*, in relation to Section 40(2) of the FOIA 2000
