Our HART vehicles were owned, are disposed of through Merthyr Vehicle Auctions in Wales. This company is a specialist blue light auction house - [Merthyr Motor Auctions - The Largest Direct Fleet Auction in the UK](#). If leased, they are returned to the lease company.

Please be advised that some HART vehicles including WX18GVY may get repurposed within other areas of the trust at the end of its life on the HART fleet.
