The Trust is in receipt of your Freedom of Information Act 2000 (FOIA) request, thank you. This request has been assigned the internal reference quoted above; please ensure that you quote this number in any future correspondence.

We have now provided a formal response below.

## **FOI Request**

You asked us:

The Care Quality Commision is the independent regulator of the Ambulance Service and the NHS. In a statement provided to me, the CQC said NHS Trusts are required to report every alleged incident of sexual misconduct by its staff, regardless if such alleged incident occurred within or outside hospital premises.

- 1. Could you please confirm that from January 2019 until present day, the total number of your employees accused of child sexual abuse remains less than 10? Please update accordingly if there has been further updates.
- 2. Could you please confirm if you notified the CQC about any of these cases? Please also confirm if you notified any other regulatory body or NHS England about these cases.
- 3. In the unlikely circumstances that neither the CQC nor NHS England was notified about these cases, please explain in detail your reason for not doing so.

## **Formal Response**

The Trust confirms it holds part of the information you requested.

1. Could you please confirm that from January 2019 until present day, the total number of your employees accused of child sexual abuse remains less than 10? Please update accordingly if there has been further updates.

The Trust confirms this number remains lower than 10.

2. Could you please confirm if you notified the CQC about any of these cases? Please also confirm if you notified any other regulatory body or NHS England about these cases.

As per contractual requirements, the CQC and ICBs have been notified of all relevant cases of concern that have police involvement as all these cases would. Regulatory bodies would also be notified as required by our contracts.

3. In the unlikely circumstances that neither the CQC nor NHS England was notified about these cases, please explain in detail your reason for not doing so.

The Trust does not withhold notification as set out in contractual requirements.

We have provided a link below to the section of the CQC's online guidance covering allegations of abuse, and notification thereof. This is publicly available. The guidance defines circumstances whereby a care provider must notify the CQC, concerning allegations of abuse. This is part of a larger body of guidance regarding notifications to the CQC, and how they are mandated for registered providers such as SECAmb.
