SECAmb has granted Merthyr Motor Auction permission to dispose / sell emergency vehicles with livery and blue lights fitted as part of an ongoing agreement. Merthyr Motor Auctions are an approved blue light auction company

No - Merthyr Motor Auctions are an approved Blue Light Auction Company who have thorough processes in place to vet the purchaser to confirm if they are linked to a blue light



company. If they are not, then all livery, blue light & control systems are removed from the vehicle before concluding the sale.

7. Do you have a contractual period for the use of Merthyr Motor Auctions and if so when does the contract expire?

There is no current contract in place
