The total Trust "On" Framework agency expenditure for the period January 2024 to March 2025 was £2,980,492.

No doctors/Nursing/AHP/HSS staff have been recruited through agencies during this period.

These would be generic agency costs for short term shifts i.e. in our Emergency Operations Centres / NHS 111 contact centres for gaps in rota. The Trust recruits permanent staff directly and through our internal recruitment processes.
