The Trust is an Ambulance Trust and therefore does not have nurse specialities.



The Trust, however, does employ registered nurses as part of our clinical advisor workforce that deliver telephone triage and advice as part of the Trusts 999 and 111 service.

Clinical advisors include registered nurses, pharmacists, paramedics etc. As part of a multidisciplinary team.

The Trust is unable to identify those agency staff that are specifically registered nurses, however the Trust spent £223,208 on clinical advisors for the month of April 2025.
