The Trust confirms it holds part of the information you have requested.



Q1. For the following years, please indicate how many people were pronounced dead following the arrival of an ambulance (Dead on Arrival)?

Please note the following caveats regarding the above data:

The count provided in response to Q1 is validated totals, for attended incidents, where no meaningful attempt at cardiopulmonary resuscitation (CPR) was made, where the patient was recorded as being beyond medical help. This is the closest dataset available, to match your request for 'dead on arrival'.

SECAmb operatives do not 'pronounce' or certify patient death. They may make an assessment of; a patient's vitals and observations, viability of attempting or continuing with CPR, patient wishes or recorded declarations, and many other factors drawn from clinical and operational guidelines and experience. If the result of the assessment is a decision not to attempt CPR, this will be recorded by the operative. This data will likely be validated under the classification 'beyond medical help'.

In April 2024, the Trust changed the classification of patients beyond medical help, where they also had a record declaration known as 'Do not attempt resuscitation' (DNAR). Before this date, if a patient was beyond medical help (e.g. had rigor), and had a DNAR, this would be recorded as beyond medical help. From this date forward, the recording of a patient's DNAR is now prioritised; some patients who would previously have been classified as beyond medical help are now classified as DNAR patients. The registry where this 'reason for no resuscitation' data is validated records only one of these two options. This accounts for the marked decrease in the number of patients recorded as beyond medical help for 2024 compared to previous years.

Q2. Of these people, how many deaths were attributed to drug related causes?

Q3. Of these people, how many deaths involved an opioid/opiate?

The Trust cannot provide an output for Q2 or Q3. Clinical causation data for patients beyond medical help is not validated alongside the 'reason for no resuscitation' figures.
