You asked us:

Can you please tell me how much your trust has spent on bariatric transport in each of the following years: 2020, 2021, 2022, 2023, 2024 and 2025 so far.

This could be purchase of specialist bariatric vehicles or chassis, rental of specialist bariatric vehicles or private hire of specialist bariatric vehicles.

Can you provide information on each purchase, including the vendor or supplier, the product or service purchased and the cost.

Formal Response

The Trust confirms it holds part of the information you have requested.

During the time period requested, the Trust has not purchased, hired, or procured any contractual service to provide, specialist bariatric services, vehicles, vehicle chassis, or vehicle conversions. SECAmb operates specialist bariatric capable vehicles, however, no new vehicles of this specification were required since 2020.

During the same period, the Trust has made small supplementary equipment related purchases, all with Ferno (UK) Limited, at a total cost of £9,425.96.
