### **Formal Response**

The Trust confirms it holds the information you have requested.

- 1. Agency Registered Nurses (all specialities e.g. adult nursing, children's nursing, community, mental health, midwives, etc) – June 2025**

The Trust is an Ambulance Trust and therefore does not have nurse specialities. The Trust, however, does employ registered nurses as part of our clinical advisor workforce that deliver telephone triage and advice as part of the Trust's 999 and 111 service.

Clinical advisors include registered nurses, pharmacists, paramedics etc., as part of a multidisciplinary team.

The Trust is unable to separately identify those agency staff that are specifically registered nurses, however, the Trust spent £101,271 on clinical advisors for the month of June 2025.
