We now have new condition codes, and we are currently looking at ethnicity data capture so reporting will improve over time.

* Data blurring at less-than-5: The Trust can confirm that this information exists. This practice is known as data blurring, which serves to mitigate against the risk of possible re-identification of individual data subjects via data recombination (sometimes referred to as jigsawing).
