Thank you for your request for information, which we received on **23/02/2026**. We have considered your request under the Freedom of Information Act 2000. **Please ensure you quote the Internal Reference number above in any future correspondence.**

Your Request

For the past three years for which full data is available, could you please provide procurement data including cost and number of units for the following items purchased by the Trust:

1. Scissors, including surgical and disposable and single-use versions.
2. Forceps, including artery or tissue forceps.
3. Surgical clamps.
4. Basic hollowware, including gallipots, kidney dishes, instrument trays and bowls.
5. Single-use tourniquets.
6. Harmonic shears.

For each item category, please provide for each year:

- a) Total number of units procured
- b) Total spend (£)



c) Where recorded in procurement systems, whether the items were designated as single-use/disposable.

Additionally, for the same three financial years, please provide:

The Trust is withholding the total spend for each individual product under section 43(2) of the Freedom of Information Act 2000, as disclosure would be likely to prejudice the commercial interests of the Trust and its suppliers.

Section 43(2) of the Freedom of Information Act 2000 is a qualified exemption and the Trust has therefore considered the public interest test.

The Trust recognises that there is a strong public interest in transparency and accountability regarding the expenditure of public funds, particularly within the NHS, and in enabling public scrutiny of procurement practices for clinical supplies. Disclosure can promote confidence in the Trust's stewardship of resources and inform debate about value for money and sustainability in healthcare procurement.

However, the Trust also considers that there is a substantial public interest in protecting commercially sensitive information relating to procurement conducted through NHS Supply Chain frameworks. The requested information relates to detailed expenditure for specific medical products supplied under live contractual arrangements within a competitive market. Disclosure of this information would be likely to prejudice the commercial interests of both the Trust and its suppliers by revealing commercially sensitive pricing structures, weakening suppliers' competitive positions, and reducing the Trust's ability to negotiate effectively and secure best value in future procurements.



The Trust considers that maintaining effective competition within NHS Supply Chain frameworks, protecting the integrity of contractual relationships, and ensuring the Trust is able to obtain essential clinical supplies at the most economically advantageous terms is itself a significant public interest. Any prejudice to the Trust's commercial position would ultimately risk increased costs to the public purse.

On balance, while acknowledging the public interest in transparency, the Trust considers that this is outweighed by the public interest in maintaining commercial confidentiality in this instance. The Trust has therefore concluded that the public interest favours maintaining the exemption.

There is no total spend or central record of the mobility aids mentioned as the Trust does not procure crutches, walking frames or walking sticks. There are no units that are refurbished or reissued through reuse schemes.
