I am writing in response to your enguiry under the Freedom of Information Act 2000 (FOIA) reference FOI/15/03/17.

You requested the following information:

Please can you tell me how many households in the South East Coast Ambulance Service area will not be visited by staff without first seeking police assistance - ie how many households are currently on the service's Location Alert Register.

We are mindful of our duty to our staff and do not want to expose them to any unnecessary hazards which includes incidents where they may be subjected to potential violence. In making this assessment however, we do not deem it appropriate to "flag" entire areas, but instead will history mark individual addresses where and when it is appropriate. These history markers are regularly reviewed to ensure that the risk associated with the individual remains potential and real.

The Trust maintains a log of addresses where the patient/s (or other residents at the address) concerned are considered to represent an actual or potential danger to our staff.

A red marker relates to the highest risk category and is defined as those addresses where information available makes it clear that staff have been physically assaulted or threatened with violence.

An amber marker relates to those addresses where information available makes it clear that there is a potential risk to crews, or of abusive, aggressive/ inappropriate behaviour.

When The Trust responds to a marked address, the Emergency Operations Centre will alert the attending crew to the nature of the marker to ensure they are aware of the potential risk; in some cases this will include instructions to await the arrival of the police prior to approaching the property in question.



As at February 2015 I can confirm that there were 29 addresses with red markers in our region and 33 addresses with amber markers.

Please can you tell me how many households in Sussex will not be visited by staff without first seeking police assistance – ie how many households in Sussex are currently on the service's Location Alert Register.

We only hold details of the current addresses which have red or amber markers.

Please can I have a breakdown of the addresses currently on the service's Location Alert Register.
