I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/15/03/20.

You requested the following information:

Since the 8th April 2013,

a) How many instances have ambulances attended 'call-outs' to somewhere in Thanet? Please give the location of same.

The following information has been broken down into two financial years; the first is from 8th April 2013 to 31st March 2014 and then 1st April 2014 to 31st March 2015. Please see the table below which shows this information:

Financial Year	Number of responses to Thanet area

Due to the large numbers involved we are unable to provide the locations within the Thanet area.

b) How many of these were dealt with at the scene?

Please see the table below which shows this number of incidents where the patient was not transported to hospital.

During the above periods patients have been transported to other hospitals but these numbers are very low and have therefore not been included in the tables above.

Also, if possible, who decides where the casualty should be taken?

The ambulance crew decide which hospital the patient is taken to; this is mostly based upon which hospital with an A&E department is closest to where we attend the patient. There are exceptions, for example, FAST test positive (stroke) patients, trauma patients and patients requiring specialist



cardiac treatment. These patients will be taken to the nearest specialist centre for their condition based upon agreed pathways.

In addition not all hospitals have full A&E departments. In such cases there is agreed acceptance criteria for ambulance staff to follow.

On occasion ambulance staff may decide to take a patient to a hospital slightly further away, if their clinical condition allows, should there be an appropriate reason to do so, such as specialist clinical treatment previously/currently received at that hospital.
