I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/15/06/20.

You requested the following information:

I wish to request information about the money spent by your trust on private firms for ambulance services.

Specifically, I would like information on:

1. The amount spent by your Trust on private and voluntary services to provide 999 care. This should be broken down, year by year, for the last five years.

We are continuing to look at ways in which we can reduce our reliance on the use of private ambulance services and always prioritise using our own staff whenever possible. However, along with all ambulance services nationally, South East Coast Ambulance Service NHS Foundation Trust (SECAmb) does use private ambulance providers when faced with high levels of demand, when experiencing high call volume or during periods of bad weather.

We have robust governance arrangements in place for the procurement of private ambulance services. While working on our behalf any private provider will be subject to a continuous monitoring and assessment process, to ensure they are providing a high level of service.

Please see the table below which shows the breakdown of expenditure between private ambulance providers and voluntary ambulance services per year for the last five financial years.

Private ambulance providers are used when the Trust is experiencing high levels of demand, high call volume or during periods of bad weather.

Medical Services Limited (MSL) UK Specialist Ambulance Services (UKSAS) Surrey Ambulance Services Ltd (SITES) British Red Cross (BRC) St John Ambulance (SJA) Blue Star Medical (BSM)

4. How many emergency calls per month now receive a response from a private ambulance? This should be broken down year by year, for the last five years.

Please see the attached spreadsheet which shows this information broken down by month for each financial year. These figures represent a count of when a Private Ambulance Provider attended the incident, not necessarily the first or only resource attending.

To put these figures into context please see the table below which shows the total number of emergency responses made by SECAmb for each of the financial years.
