I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/02/03.

You requested the following information:

1. Can you tell me how many recorded handovers there were between ambulance crews and the following hospitals between October 1 2015 and January 31 2016?

Royal Sussex County Hospital, Brighton Princess Royal Hospital, Haywards Heath Worthing Hospital St Richard's Hospital, Chichester Eastbourne District General Hospital Conquest Hospital, St Leonards.

Please see the attached document showing the total number of handovers for the above mentioned hospitals from 1st October 2015 up to 31st January 2016.

Please note that there is a column for handovers and one for recorded patient handovers. This is because not all handovers are recorded in the A & E department due to patients being taken to directly to other wards or specialist departments/ units within the hospital.

2. How many of these handovers took more than 30 minutes, broken down to each hospital?

Please see the attached spreadsheet which shows the number of patients waiting more than 30 minutes before being handed over to hospital staff.

3. How many of these handovers took more than one hour, broken down to each hospital?



Please see the attached spreadsheet which shows the number of patients waiting more than 60 minutes before being handed over to hospital staff. The figure for those patients waiting longer than 60 minutes will be included in the greater than 30 minutes figure.

4. What was the longest recorded wait at each hospital during this time?

Please see the table below which shows the longest period of time for patients to be handed over at these hospitals in our area during the period from 1st October 2015 and 31st January 2016.

I have to make you aware that this data is unvalidated and has not been agreed with the hospitals however we have checked our data thoroughly to ensure that there are no recording errors.
