I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/05/22.

You requested the following information:

1. Actual DMA and RRV resources provided to the public in the Worthing, Shoreham and Brighton areas from 0800 Saturday 9th May 2015 to 0800 11th May 2015.

Please see the attached spreadsheets which show the shifts worked on each day together for Double Crewed Ambulances (DCAs) and Single Response Vehicles (SRVs). Where the vehicle type is indicated as P/P this would be a Single Response Vehicle also. Our information is based on the control room's dispatch desks for Brighton and Worthing.

2. Predicted resource levels v actual levels provided for the same period.

Please see the table below which shows this information in hours and for DCAs and SRVs required and provided for each day.

4. Actual Staff sickness levels for the same period and in the same area.

There was a total of 9 staff off sick totalling 92.4 hours for this period of time and from the stations previously mentioned.

5. Details of any extra resources provided within this area funded directly by the Trust to maintain cover due to the Wild Life Festival.

Extra resources were provided by Private ambulance providers as shown in the information attached. This is indicated by the initials PAS (Worthing).

6. What impact if any did the Wild Life Festival have on the 999 response in the Worthing and Shoreham area.
