I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/06/13.

You requested the following information:

1. From January 2016 to May 2016, what is your total number of shift hour requirements for paramedics?

The following responses all relate to frontline A & E staff, not just paramedics.

2. What is the total size of the paramedic bank staff population as of June 2016

There are 153 A&E (frontline) staff recorded on our Electronic Staff Records database with a bank assignment as at 31 May 2016.

3. From January 2016 to May 2016, what is the average number of paramedic shift hours covered by Bank staff?

An average of 16 shifts per day Trust wide.

4. From January 2016 to May 2016, what is the average number of paramedic shift hours covered by agency staff?



None.

5. What is the hourly rate paid to an agency when engaging their paramedic services?

I have to advise that I am unable to provide this information on the basis of the exemption contained within s43 (2) of the FOI Act (Commercial Interests). The Trust accepts that there is a public interest in how public money is spent; however there is also a need to withhold information that would prejudice the commercial interest of the Trust and/ or third parties. 6. From January 2016 to May 2016, how much have you spent on recruitment agencies between April 2015 and March 2016 on paramedic staff?

We do not use agencies for paramedic staff.

7. How often do you review your paramedic agency preferred supplier lists?

We do not use agencies for paramedic staff.

8. Do you employ NHS 111 Clinical Advisors?

Yes.

9. If so, Do you use agencies to provide NHS111 Clinical Advisors?

10. On a monthly basis, what is the average number of NHS 111 Clinical Advisors shift hours covered by agency staff?

Out of 2000 hours a week, 400 are covered by agency clinicians – approximately 20% of planned Clinical Advisor hours across both sites, Ashford and Dorking.

11. What is the hourly rate paid to an agency when engaging their NHS Clinical Advisor services?
