I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/06/42.

You requested the following information:

For the financial years 2011-12, 2012-13, 2013-14, 2014-15 2015-16 and 2016-17 to date:

1. How many emergency calls have you received from people suspected to have taken legal highs or NPS (new psychoactive substances)?

Please see the tables below which show information based on searching under the freetext of 'legal high' and 'spice'. A search was also conducted under the freetext of 'NPS' and 'New Psychoactive substances' but no details are held under these. I would like to stress that these figures are based on the information provided by the caller during triage of the 999 call which may prove different to what our crews find when they reach the patient, therefore the detail given by the caller may not always be accurate. This figure will include electronically transferred calls from NHS 111.
