I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/08/24.

You requested the following information:

Under the Freedom of Information Act 2000, please can you provide me with:

1) The annual number of times the service was called out to a Pupil Referral Unit, per individual reason for callout per Pupil Referral Unit, for each of the last 5 years

2) The monthly number of times the service was a) called out to and b) attended Pupil Referral Units within your jurisdiction, per Pupil Referral Unit, for each month in the last 5 years

Please find an attached spreadsheet detailing addresses of PRUs called 'PRUs'.

Please send me the data requested in the form of an Excel spreadsheet or as a csv file, ideally in the form of the attached response template called 'PRU FOI Table template'.

South East Coast Ambulance Service NHS Foundation Trust covers Kent, Surrey (not London), Sussex and North East Hampshire. The Pupil Referral Units listed on your spreadsheet that are located within our area are shown below. There are some locations where no responses have been made. I would like to make you aware that the attendance could relate to a pupil, staff member or a member of the public in or outside the location given.

Please see the attached spreadsheet which shows the number of calls from and responses to each pupil referral unit for each of the last 5 years. Due to the small numbers we cannot break this information down into monthly detail or provide the reason for the response on the grounds of the exemption contained within s40(2) of the Freedom Of Information Act (FOIA) 2000 – Personal Information .

Section 40(2) states:

Any information to which a request for information relates is also exempt information if-

- (a) it constitutes personal data which do not fall within subsection (1)\*, and
- (b) either the first or the second condition below is satisfied.

(3) The first condition is –

(a) in a case where the information falls within any of the paragraphs (a) to (d) of the definition of 'data' in section 1(1) of the Data Protection Act 1998, that the disclosure of the information to a member of the public otherwise than under this Act would contravene-

(i) any of the data protection principles, or

(ii) section 10 of that Act (right to prevent processing likely to cause damage or distress), and

(b) in any other case, that the disclosure of the information to a member of the public otherwise than under this Act would contravene any of the data protection principles if the exemptions in section 33A(1) of the Data Protection Act 1998 (which relate to manual data held by public authorities) were disregarded.

(4) The second condition is that by virtue of any provision of Part IV of the Data Protection Act 1998 the information is exempt from section 7(1)(c) of that Act (data subject's right of access to personal data).

\* subsection (1) states: Any information to which a request for information relates is exempt information if it constitutes personal data of which the applicant is the data subject.

Section 7(4) of the Data Protection Act 1998 states:

Where a data controller cannot comply with the request without disclosing information relating to another individual who can be identified from that information, he is not obliged to comply with the request unless—

(a) the other individual has consented to the disclosure of the information to the person making the request, or

(b) it is reasonable in all the circumstances to comply with the request without the consent of the other individual.

We cannot provide the requested information as we do not have the consent from the above named individuals to provide this.
