I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/16/09/30.

You requested the following information:

I want to find out how many incidents requiring investigation there have been following contact with any part of the ambulance service in the last five years? Investigations at levels 1,2 and 3 should be included. Could you give me a breakdown by year and also whether the contact under investigation was after a NHS ambulance service was engaged or after a private provider was engaged please?

We are unable to provide information relating to whether a Private Ambulance Provider was involved in Serious Incidents prior to 2013/2014 as a different reporting database was used at that time. However we can provide this information for the financial years from 2013/2014 to 2015/2016. Please see the requested information listed below:

The total number of Serious Incidents reported during the last five financial years is 207.

(1st April 2011 – 31st March 2012) Number of Serious Incidents reported: 22 Number of these Private Ambulance Provider related: Unknown

## 2012/13

(1st April 2012 – 31st March 2013) Number of Serious Incidents reported: 31 Number of these Private Ambulance Provider related: Unknown
