You requested the following information:

## Which new medications are planned to be introduced to a standard band 5 paramedic, likewise to a band 6 paramedic.

There are no plans to introduce any new medications to band 6 paramedics. Please see below regarding band 5 paramedics.

# Are there any plans for band 5 paramedics - normal operations to administer ketamine, midazolam or fentanyl in the next year ?

There are plans to use midazolam but no others have been formally discussed.

# Are there any plans for paramedics to be able to cardiovert or pace - if so which group of paramedics.

Critical Care Paramedics provide chemical and electric cardioversion and transcutaneous pacing. There are no plans to expand this service.

# Are there any plans to pay standard paramedics band 6, and specialists band 7 i.e PP or CCP?

Under the FOI Act, we can only provide information held by the Trust relating to the Trust. We cannot provide details of any plans for the future.
