## Ambulance and Specialist Vehicle Supply Framework Contract



The procurement exercise for this framework was managed by the Asset Finance Team at Capita Asset Services (Capita) in collaboration with South East Coast Ambulance Service NHS Foundation Trust in order to establish a single and comprehensive Ambulance and Specialist Vehicle Supply Framework Contract ("Framework Contract"). This Framework Contract is accessible by all NHS Ambulance Service Trusts and other emergency service providers along with a number of other organisations located in the United Kingdom (Eligible Bodies) to procure:

- ambulance and other specialist vehicle builds;
- vehicle refurbishment;
- body remounts;
- lease finance;
- maintenance management; and
- contract hire.

Other services (such as short term hire of ambulance and specialist vehicles and Service, Maintenance and Repair (SMR) solutions) that are clearly related to the core focus of this Agreement can also be secured using this Framework Contract.

### Key benefits

The Framework Contract offers the user access to the key providers in each of the respective markets covered, combining a high degree of flexibility with ease of use and offering the following key benefits:

- Removes the necessity for a separate OJEU (Official Journal of the European Union) tender procedure
- Reduced procurement timescales
- Offers access to our suite of pre-agreed preferential and market specific contract documentation
- Discloses information required for evaluation/classification under IAS 17/IFRS (International Financial Reporting Standards)
- Incorporates a code of practice that has been jointly developed by Capita and NHS Protect which lays out a responsible and secure approach to the decommissioning and onward sale of ambulance vehicles. The code of practice has been agreed by all lease finance and contract hire companies on this Framework Contract.

### OJEU (Official Journal of the European Union)

The Framework Contract has been established following a full OJEU advertised procurement exercise and quotations may be secured by any Eligible Body from the converters and finance/maintenance companies via a mini-tender without the need to revert to a lengthy EU tender process.
