I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/17/08/21.

You requested the following information, please also see our response below:

1. Please advise, to the trust's knowledge, of the total number of inquests involving trust patients in the last five financial years (1 April 2012 to 31 March 2017). Please advise for the following periods:

1 July 2013 to 31 March 2014 - 299 Financial year 2014/15 - 397 Financial year 2015/16 - 502 Financial year 2016/17 - 461

Please note the number above is for all cases relating to requests for health records – this includes solicitors, coroners and police requests. To determine how many of these are specifically for inquests would mean going through each individual record and would exceed 18 hours and would therefore fall under Section 12- FOI (Appropriate limit and fees) Regulations 2004

2. How many coroners' Section 28 reports on action to prevent future deaths has the trust received?

The Chief Coroner publishes all the Section 28 reports and only some of the responses. If the Coroner has not published them, we would not release them as they contain patient identifiable data and would therefore be exempt under Section 40 (2) – Data Protection

## 6. Please advise if the trust has since audited the implementation of its action plans in response to Section 28 reports.

I hope you find this information of some assistance. As you will see, there is some information that we have not historically held and this is in part due to us not having a specific resource. Earlier in 2017, as part of the Trust's improvement plan, we established a dedicated legal services team.
