# 1) How many choking incidents did your Ambulance Trust attend for the year 2016 and also 2017?

Please note that the problem nature is determined by the call taker, and not a diagnosis, what was found when a crew arrived on scene or what the patient was treated for if conveyed to hospital.

**2)** How many of these incidents were attended where the casualty was no longer breathing? To extract this information would mean going through each individual record and exceed 18hours and would therefore fall under Section 12- FOI (Appropriate limit and fees) Regulations 2004

- Laryngoscope handle £4.15
- Layngoscope blade £3.42
- Child magills £2.78
- Adult magills £2.27
