I am writing in response to your enquiry under the Freedom of Information Act 2000 (FOIA) reference FOI/18/04/05.

You requested the following information, please also see our response below:

1. How many 999 emergency call outs has SECAMB responded to in each of the financial years 2014/15, 2015/16, 2016/17 and 2017/18?

## 2. How many of the 999 call outs were in Kent only?

3. How many of the 999 call outs that SECAMB responded to in each of the financial years were alcohol related, for both the SECAMB region as a whole, and Kent specifically? Please see table below. This data shows incidents with a problem nature of alcohol Intoxication; Alcohol Intoxication/Related; or Alcohol Related.

Please note that the problem nature is determined by the call taker, and not a diagnosis, what was found when a crew arrived on scene or what the patient was treated for if conveyed to hospital.

\*Please note these figures may not be a true reflection of the number of alcohol related incidents that our staff deal with. This is because such emergencies may be categorised according to the injuries sustained while intoxicated i.e. a person may have suffered a fall while intoxicated and the call taker may therefore categorise this incident as a fall.

To establish a fuller picture of this issue we would need to review every patient care record (PCR) which would exceed the 18-hour limit and therefore be exempt under Section 12. We would advise you to contact local hospitals to establish whether they can provide better data on this issue.

## 4. How many of the 999 call outs that SECAMB responded to in the financial years were for people with mental health problems, in the SECAMB region as a whole, and Kent specifically?

Please see table below. This data shows incidents with a problem nature of Mental Health; or Mental Health Issues.

Please note that the problem nature is determined by the call taker, and not a diagnosis, what was found when a crew arrived on scene or what the patient was treated for if conveyed to hospital.

Please note these figures may not be a true reflection of the number of mental health related incidents that our staff deal with. This is because such emergencies can be categorised in many different ways depending on the nature of the emergency.

To establish a fuller picture of this issue we would need to review every patient care record (PCR) which would exceed the 18-hour limit and therefore be exempt under Section 12. We would advise you to contact local hospitals to establish whether they can provide better data on this issue.
