You requested the following information, please also see our response below:

Ambulance crews wait with the patient prior to handover although not in the ambulance itself. The data below refers to the time between arrival at the destination hospital and handover to hospital staff for all recorded handovers. Please note this data is for hospital handovers to any department (not just accident and emergency).

There were 141 incidents reported of handover delays between 1st April 2017 and 31st March 2018. Out of these incidents there were 16 where crews treated patients on hospitals grounds
