The above data has been obtained using the following out of service (OOS) reasons:

- Breakdown
- Vehicle recovery / mechanic

Please note that the OOS times will only capture instances where the vehicle broke down during a crew's shift and ends when the crew's shift finishes or when they moved to a replacement vehicle. Essentially, OOS reasons only account for time lost – e.g. the length of time a crew are broken down and unable to respond to patients.
