All grades of clinicians are able to respond to calls categorised as life threatening. Upon arrival, it may not be as given and within the skill set of the arriving clinician, not requiring additional resourcing. All resources can request additional paramedic back up if required.

3. Please provide details for the number of weeks of training undertaken by care assistants before they are allowed to attend 999 callouts on their own?

We do not have care assistants. Each Emergency Care Support Worker (ECSW) currently attends a 4 week clinical course, followed by an emergency driving course (4 weeks), they then attend a local induction at the operating unit they have been assigned to. This includes shadowing/third manning and a period of time with an established mentor. ECSWs role is to assist the Paramedic or Technician/Associate Practitioner and are typically crewed up with an experienced member of clinical staff

4. If possible, please state the current vacancy rate amongst paramedics within your ambulance trust. Please provide this figure as a percentage.

24.8% as of 31st August 2018
