Within HR SAR's are allocated to a HR Case Handler. Currently there are 4 HR
Business Partners who would be allocated a case to lead. This may be supported by
an HR Advisor when appropriate. This forms part of their overall duties. In addition,
there is an allocated HR Administrator and HR SAR Lead to which SAR's forms part
of their overall duties
